Description: The New York State Bridge Authority (NYSBA) is soliciting bids for the "Empire State Trail" project at the Kingston-Rhinecliff Bridge. Construction of this segment of the Empire State Trail shall begin at Rte. 32 in Ulster County and cross the Kingston-Rhinecliff Bridge over the Hudson River and connect the trail at the intersection of Rte. 199/River Road in Dutchess County. The scope of work for this project involves the construction of a 5ft. wide asphalt pathway, drainage installation, installation of 8400lf of "new" temporary concrete barrier (stiffened with box beam), pedestrian traffic signalization and pavement markings as shown on the contract drawings.

Bid documents are only available electronically.
