Description: The New York State Bridge Authority is soliciting bids for the "Catwalk Lowering and Electrical Upgrade" project for the Newburgh-Beacon Bridge, 7800lf deck truss structure over the Hudson River in Beacon, New York. The scope of work for this project is to lower and modify the existing catwalk; install top and mid-rails and toe-plates for OSHA compliance; furnish and install new caged access ladders; furnish and install new catwalk between Pier 4 and Pier 7; furnish and install new electrical cable tray and bridge wiring. Lane closure restrictions will be strictly enforced as noted on the contract drawings.
