Description: The New York State Bridge Authority is soliciting proposals from firms of licensed professional engineers to design the deck replacement for the Newburgh-Beacon Bridge North Span. All SEQRA tasks and all necessary permit pre-applications are a part of this assignment.

The successful consultant shall evaluate various deck replacement systems for use on this project, including panelized or modular deck replacement systems. The consultant shall also evaluate work zone traffic control (WZTC) schemes and their impacts to traffic delays, the performance of the rehabilitation work and the effect to the overall project schedule.

The successful proposer will demonstrate to NYSBA a successful history of similar performance for operators with bridges of the type and size of NYSBA's facilities. Successful proposer will not propose a design scheme at this time, but should demonstrate expertise in design and familiarity with the standards of traffic control, environmental protection, and civil and structural engineering, as well as with NYSBA's bridges themselves.

Requirements: Firms must be licensed, professional engineers with extensive experience with NYSBA, NYSDOT or other government agencies. Firms must comply with NYSBA's Equal Employment Opportunity Program, M/WBE and SDVOB goals.
