Contract Title: Deck Replacement - Newburgh-Beacon Bridge, South Span

Description:

The New York State Bridge Authority is soliciting bids to replace the roadway deck for the 7,800 foot long Newburgh-Beacon Bridge south span. The scope of work consists of deck demolition and the installation of a modular/panelized replacement deck system. Other construction activities include replacement of the electrical system, installation of new parapet walls, resetting deck expansion joints and steel repairs. The majority of construction work will be performed at night with three (3) of four (4) lanes opened to traffic each and every day during peak hours (6:00am - 9:30am and 3:00pm - 6:30pm). This project is subject to a Project Labor Agreement (PLA) in accordance with NYS Labor Law 222. Prospective bidders shall sign the PLA to validate their bid submission.
