Description: The New York State Bridge Authority (NYSBA) is requesting proposals from firms of licensed professional engineers to analyze and design steel repairs for all Priority 1 and 2 conditions noted in the 2012 Walkway Over the Hudson Inspection Report. All SEQRA tasks and all necessary permit pre-applications are a part of this assignment.

The successful proposer will demonstrate to NYSBA a successful history of similar performance for operators with bridges of the type and size of NYSBA's facilities. Successful proposer will not propose a design scheme at this time, but should demonstrate expertise in design and familiarity with the standards of traffic control, reinforced concrete structures, environmental protection, civil and structural engineering as well as with NYSBA's bridges themselves.

Requirements: Firms must be licensed professional engineers with extensive experience with NYSBA, NYSDOT or other government agencies. Firms must comply with NYSBA's Equal Employment Opportunity Program, M/WBE and SDVOB goals.
