Description: The New York State Bridge Authority is soliciting technical and cost proposals from Consulting Engineering firms for Construction Inspection Services of a railing rehabilitation project at the Walkway Over the Hudson (WOTH). The WOTH is a 6,769 foot long pedestrian truss structure over navigable waters of the Hudson River. Environmental protection and safety of the pedestrians and mariners are high priorities for this project. Personnel with comparable experience will be highly valued in the selection process. Inspection staff shall be thoroughly familiar with Authority policies and the NYS M.U.R.K manual.

Work will include removing, storing and reinstalling the south bridge railing and fencing; performing railing post anchor rod grout pocket repairs and deck panel fascia repairs; replacing lighting, telephone and power wiring and conduit; and replacing security cameras. Although the contract allows for daytime work, the Contractor is very likely to perform the railing removal and reinstallation during the night.

Requirement: Firms must be licensed professional engineers with extensive experience with the NYSDOT, Bridge Authority or other government agencies. Firms must comply with the Authority's Equal Employment Opportunity Program, WBE/MBE goals.
