Building Envelope" project at the Newburgh-Beacon Bridge. The scope of

renovation work includes installation of new windows, an exterior shell, new-sloped roof, replacement exterior doors and a new heat pump system. The maintenance building is located at the northeast end of the westbound 1-84 Newburgh-Beacon Bridge. This building is occupied and located in an area with active Bridge Authority personnel and vehicles flowing constantly throughout the area. All precautionary

measures for protection of the area shall be as determined by NYSBA.
